6. The objects for which the corporation is incorporated are:
Objets pour lesquels l'association est constituée:

- a) To enhance, promote and preserve the historic presence of the former Ontario Provincial Air Service at Sault Ste. Marie, and the more than 100 years of forest fire fighting in Ontario, through the establishment of a public museum facility in Sault Ste. Marie on the site of the current air services operation at 55 Church St.
- b) To acknowledge and preserve the contributions made to the development of the Province of Ontario by those individuals known as bush pilots, and their ground crews, and the professional operators past and present whose many and varied contributions and services helped develop, guide and form the Ontario northland in this century.
- c) To search out, collect, restore and exhibit examples of period aircraft, forest fire fighting equipment, and related equipment and memorabilia, for the education of the general public, and to illustrate current forest fire management technology.
- d) To maintain the historic perspective and purpose of the provincial air service at Sault Ste. Marie, and to preserve the historic, architectural presence of the aviation hangar facility.
- e) To utilize forest fire fighting displays and exhibits to further an awareness of the careless use of fire in our forests; to underline the economic importance of forestry to Northern Ontario communities, and to the Province of Ontario; to complement the forest fire prevention efforts of the Ministry of Natural Resources through awareness and education.
- f) To create an opportunity to utilize the skills and expertise of the many people interested in this undertaking, and especially the rare skills required in the restoration and rebuilding of vintage aircraft, and communications and fire suppression equipment; and to preserve and pass on those skills and the knowledge of those craftsmen through restoration projects.

7. The special provisions are/Dispositions particulières:

For the above objects, and as incidental and ancillary thereto, to solicit and receive donations, bequests, legacies and grants, and to enter into agreements, contracts and undertakings incidental thereto:

- a) The corporation shall be carried on without the purpose of gain for its members and any profits or other accretions to the corporation shall be used in promoting its objects.
- b) The corporation shall be subject to the Charities Accounting Act and the Charitable Gifts Act.
- c) The Directors shall serve as such without remuneration and no Directors shall directly or indirectly receive any profits from their position as such, provided that Directors may be paid reasonable expenses incurred by them in the performance of their duties.
- d) The borrowing power of the corporation pursuant to any by-law passed and confirmed in accordance with section 59 of the Corporations Act shall be limited to borrowing money for current operating expenses, provided that the borrowing power of the corporation shall not be so limited if it borrows on the security of real or personal property.
- e) Upon the dissolution of the corporation and after the payment of all debts and liabilities, its remaining property shall be distributed or disposed of to charitable organizations which carry on their work solely in Canada.
- f) If it is made to appear to the satisfaction of the Minister, upon report of the Public Trustee, that the corporation has failed to comply with any of the provisions of the Charities Accounting Act or the Charitable Gifts Act, the Minister may authorize an inquiry for the purpose of determining whether or not there is sufficient cause for the Lieutenant Governor to make an Order under subsection 317(1) of the Corporations Act to cancel the Letters Patent of the corporation and declare it to be dissolved.
